

# ALVARADO PRIVACY STATEMENT

Alvarado Mfg. Co., Inc. ("Alvarado" or "we" or "us") is committed to protecting the privacy of your personally identifiable information that you submit to Alvarado's website located at: <u>www.alvaradomfg.com</u> and other subdomains and sites that may be operated by Alvarado (the "Site"). This Privacy Policy details certain policies describing how we collect, use and store "Personally Identifiable Information" (such as name, email address, street address and telephone number) from users of our Site and users of any available services on the Site.

#### Information Collected on Site

The majority of the information provided by Alvarado on the Site is available without Alvarado collecting any Personally Identifiable Information from you. You can review almost the entire Site without disclosing any Personally Identifiable Information. However, Alvarado does collect Personally Identifiable Information that you may voluntarily provide to us. #### How We Use Your Information

Alvarado uses any Personally Identifiable Information you provide in a limited number of ways. ### How We Share Your Information

We will not disclose your Personally Identifiable Information to others without your permission, except as explained in this Privacy Policy.

## **Aggregate Information**

On an aggregate basis only, we may collect comprehensive demographic, business information and data, and other non-identifying information about users of the Site. Alvarado will never disclose any Personally Identifiable Information as part of this aggregate information but we may lend, sell, share or otherwise disclose aggregate information with others so we can perform research and provide the results to third parties, enhance and market the Site, and conduct accounting and process record keeping functions.

Our computer systems are currently based in the United States, so your personal information will be processed by us in the United States where data protection and privacy regulations may not offer the same level of protection as in other parts of the world, such as the European Union. If you use the Site and/or services offered on the Site as a visitor from outside the United States, by using the Site and/or services offered on the Site, you agree to this Privacy Policy and you consent to the transfer of all such information to the United States, which may not offer an equivalent level of protection of that required in the European Union or certain other countries, and to the processing of that information as described in this Privacy Policy.

#### Security

We may transfer your personally identifiable information to an affiliate or a successor entity upon a merger, consolidation or other corporate reorganization in which Alvarado participates or to a purchaser or acquirer of all or substantially all of Alvarado's business or assets to which this Site and/or the services offered on this Site relate.
