# Vogue Post

### Modular Post and Rail

Alvarado's modular post and railing systems are suitable for a wide variety of applications. Used inside grocery and retail stores, our railing is used to create custom sized cart corrals and, in conjunction with our turnstiles and gates, to control patron and shopping cart access. In other applications, post and rail is used to segment off areas or to create permanent queuing lines. Posts come with factory installed outlets in various configurations. Loose rails are available in various sizes or long lengths that can be cut to size in the field.

### **FUNCTION**

Vogue modular post and railing systems direct pedestrian and shopping cart traffic in stores and other facilities. Other typical uses include cart corrals (shopping cart storage areas), permanent queue lines and controlling access to segmented areas. Posts are fixed installed, using Alvarado's anchoring options. See Options section below.

### **AVAILABLE HEIGHTS**

The Vogue Post is available in 35" (889mm), 44" (1118mm) or 48" (1219mm) heights.


### MATERIALS AND FINISHES

The Vogue Post is a 2.25" OD tube made from 16-gauge steel with a 5.5" diameter anchoring flange. A base cover and post cap are included with each post. The 35" posts are available in bright chrome, stainless steel (satin and mirror finish) and powder coat colors. The 44" and 48" posts are available in bright chrome and powder coat colors.

### CONFIGURATIONS


Rail outlets are factory installed on the post to accept 1.75" OD horizontal rails (sold separately). Rails are 16-gauge steel and are available in bright chrome, stainless steel (satin and mirror finish) and powder coat colors. Available rail lengths are described in the Options section. Rail outlets can be installed in both double and triple rail configurations. Double rail outlets are available on 35" and 44" posts. Triple rail outlets are available on 44" and 48" posts. See below for all factory installed rail outlet configurations. Sperate outlets can be purchased and field installed if required.

#### 35" DOUBLE RAIL











## **OPTIONS**

### **VOGUE ANCHORING PACKAGE**

(three outlets)


The standard fixed option provides four 0.375" bolts, expansion anchors and washers (shown right).

### ZENITH ANCHORING PACKAGE

Zenith anchoring includes the Vogue anchoring package with the additional support of a threaded rod that runs top to bottom through the center of the post. The rod attaches to a 2.75" long double expansion anchor (shown right).





### **REO ANCHORING PACKAGE**

The REO anchoring package makes any Vogue style post removable. The REO kit attaches to the base of the post with four bolts. The stem inserts into a socket that has been drilled and set into the floor (shown right).

### CORE DRILLED

42" long posts are available for core drilled installation (shown right).

#### POST BUMPER GUARD

A plastic post bumper guard (shown right) attaches to any 2.25" OD post to safeguard posts and equipment from impact damage. The bumper guard has a 5.5" OD and includes two set rings for securing at a specified height (shown right).

### WALL FLANGE

The wall flange allows 1.75" OD horizontal railing to attach directly to walls or fixtures, eliminating the need for a post when space is limited. The wall flange is available in bright chrome (shown right) and custom powder coat finishes.

#### HORIZONTAL RAILING

Rails are available in lengths from 1' to6' in 3" increments (e.g., 12", 15", 18", 21"). Rails in lengths of 84", 96" and 120" are also available.

### SHIPPING


The Vogue Post ships one per box. Horizontal railing is packaged separately and quantity per box varies based on order.

### SITE PREPARATION

The Vogue Post installs on level concrete. A skilled installer should perform the installation, in consultation with the owner or end user, following safe practices and the installation guidelines that come with the product.
