


VOGUE POST

PROTECTION POST

The Vogue Post protects case, door and wall corners from impact damage from shopping and stocking carts. Vogue posts are also used for general fixture protection and to close off small open areas.



TYPICAL INSTALLATION SITES

- Supermarkets
- Retail Stores
- Food Service Areas

FUNCTION

Alvarado Vogue posts protect fixtures from damage caused by shopping and stocking carts. Posts come in standard heights, however because the posts have a removable top cap, they can be cut to size in the field. The post comes with a matching base cover which conceals installation bolts and provides a clean, finished look.

Options for installation include fixed anchored, removable and core drilled.

AVAILABLE HEIGHTS

The Vogue Post is available in 35" (889mm), 44" (1118mm) or 48" (1219mm) heights.


MATERIALS AND FINISHES

The Vogue Post is a 2.25" OD tube made from 16-gauge steel with a 5.5" diameter anchoring flange at the base. A base cover and post cap are included with each post. The 35" posts are available in bright chrome, stainless steel (satin and mirror finish) and powder coat colors. The 44" and 48" posts are available in bright chrome and powder coat colors.

OPTIONS


VOGUE ANCHORING PACKAGE

The standard fixed option provides four 0.375" bolts, expansion anchors and washers (shown right).




ZENITH ANCHORING PACKAGE

Zenith anchoring includes the Vogue anchoring package with the additional support of a threaded rod that runs top to bottom through the center of the post. The rod attaches to a 2.75" long double expansion anchor (shown right).



REO ANCHORING PACKAGE


The REO anchoring package makes any Vogue style post removable. The REO kit attaches to the base of the post with four bolts. The stem inserts into a socket that has been drilled and set into the floor (shown right).



DESCRIPTIVE SPECIFICATION POSTS AND BOLLARDS

CORE DRILLED

42" long posts are available for core drilled installation (shown right).



POST BUMPER GUARD

A plastic post bumper guard (shown right) attaches to any 2.25" OD post to safeguard posts and equipment from impact damage. The bumper guard has a 5.5" OD and includes two set rings for securing at a specified height (shown on right).

SHIPPING


The Vogue Post ships one per box.

SITE PREPARATION

The Vogue Post installs on level concrete. A skilled installer should perform the installation, in consultation with the owner or end user, following safe practices and the installation guidelines that come with the product.
